Chamber Committees

Ambassador and Membership: Comprised of volunteers, this committee's attention is geared toward providing support and assistance to local businesses through "Ambassador Walks" and is the liaison between the Chamber and its members. Also, this committee organizes the annual Dana Point Chamber Scholarship Fund for the Dana Hills High school students.

Meets on the second Tuesday of each month

Government Affairs: Centers on public policy and legislative action supporting the growth of business in Dana Point. This is not a reactive group, but a proactive committee designated to inform lawmakers of the legislative positions of our local business community.

Meets on the third Thursday of each month

Finance: Provides oversight of the Chamber's financial operations, monitors normal operating venues and expenses, and adheres to the budget established in the beginning of each fiscal year. Duties also include reviewing Chamber financial transactions, and recommending adjustments.

Meets on the second Tuesday of each month

Turkey Trot: Responsible for the largest event in Dana Point and primary fundraising event for DPCC, this committee's duties include marketing, sponsorship, logistics, public and community relations and website management for the Dana Point Turkey Trot.

Beautification: Instills a sense of community pride by recognizing businesses which have gone above and beyond in new commercial construction, revitalization of current commercial exteriors and landscaping, or have worked to preserve a historical site for business purposes. Awardees are recognized at the State of the City Luncheon in the spring.

Citizen of the Year/Business of the Year: These committees are comprised of former recipients of COTY/BOTY. Awards are presented at the Dana Point Annual Meeting and Installation Dinner. Winners are determined by committee members, not by Chamber staff.

Lantern District: The Lantern District Committee is comprised of businesses located in the Lantern District area of Dana Point. The focus of the committee is to encourage businesses to collaborate, plan, and execute the promotion and improvement of business in the Lantern District.
